

## **Our story**

### The first four years

A National Disability Research Partnership (NDRP) has long been a dream for the disability community. Funding from the Australian Government allowed work to start on the Establishment Phase in 2020. Over four years, the NDRP Working Party reached out to the disability community for advice and feedback on how a National Disability Research Partnership could best be established.

Achievements in this period include:

- Developed the <u>NDRP guiding principles</u>
- Worked with the disability community to develop the <u>NDRP</u> Research Agenda
- Set up the <u>Disability Research Collection</u> with the Analysis & Policy Observatory
- Developed a plan for strengthening disability research capacity
- Ran a pilot <u>funding</u> round to set the foundation for future funding rounds
- Developed a <u>governance structure</u> outlining who should run the NDRP and how, the first Board of Directors and the NDRP constitution
- Created an approach for research commissioned by governments and other funders
- Developed ideas about how best to mobilise evidence for action

We could not have achieved any of this without the generosity of the disability community. We are so grateful for all the knowledge, feedback and ideas shared with us over the first four years, and we look forward to this continuing for the next five years.

#### The next five years

In 2024 the NDRP was established as an independent, not for profit organisation. Thanks to significant funding from the Australian Government, we have developed guiding principles and strategic focus areas to work towards our vision of disability-led research transforming policy and practice in Australia. We will implement this over the next 5 years, using funding from diverse sources.

We will regularly share our progress in implementing this Strategic Plan as well as the outcomes of our work.
